Sealed quotations affixed with non-refundable court fee stamp of Rs 8.25 (Rupees eight & paise twenty-five) only are invited from intending suppliers/ firms for **supply of "ARROW CROSS MARK"** as and when ordered in connection with conduct of Panchayat Election as per the following terms and conditions.

 [Polymer arrow cross mark (at both ends)- cross section of
 1.5 cm x 1.5 cm and length of the bar- 10 cm]

## TERMS AND CONDITIONS

1. The envelopes containing technical bid and financial bid should be duly sealed and the envelope containing the financial bid should be put inside the envelope containing the technical bid. Both the envelopes containing technical bid and financial bid should be super scribed as "TECHNICAL BID FOR ARROW CROSS MARK" and "FINANCIAL BID FOR ARROW CROSS MARK" respectively and name of the firm/ party should be distinctly written on the cover of the envelope.

Rates should be quoted per piece of the article including GST and other taxes and valid for a period of 1 (one) year from the date of opening the tenders/quotations.

- 3. The delivery period of the materials shall be 20 days from the date of issue of the work order or as may be fixed by this office.
- 4. Each firm shall submit photo copies of: GST Registration Certificate, up to date Trade License (valid till March 2025), valid Pan Card, Previous experience, if any, along with the tender paper.

5. Bidders will have to provide samples of the items along with the tender papers.

- 6. A model of the Arrow Cross Mark is available in the office of the Assam State Election Commission for inspection with reference to its size length and mark.
- 7. Bidders will be responsible for maintaining the quality of items. If any supplier fails to supply or maintain the quality of materials, his/her order will be rejected immediately and the bid amount would stand forfeited.

8. The rates should be inclusive of all taxes.

- 9. The bidders will have to deposit an amount of Rs. 5,000/- (Rupees Five Thousand) only as security deposit in the form of Demand draft/Bankers Cheque in favour of "District Commissioner, Majuli" payable at HDFC Bank, Majuli Branch, Garamur, Majuli along with the quotation.
- 10. The security deposit will be released only after satisfactory completion of the work.
- 11. Security money will be forfeited in case of breach of conditions.
- 12. Payment is subject to satisfactory completion of the job. No advance/part payment will be made for the job.
- 13. The work may be allotted to one or more than one Firms/Suppliers depending upon the urgency of the work.
- 14. Preference will be given to bidder(s) with previous experience of supplying Arrow Cross Mark to any Govt. Department/
  State Election Commission/ DCs/SDOs(C).
- 15. Quality and specifications of the articles shall be similar to the sample submitted to the office of the undersigned.
