<u>TENDER NOTICE FOR RUNNING MAJULI BHAWAN, JORHAT INCLUDING</u> CANTEEN & HOUSE KEEPING

Sealed quotations affixing Court fee stamp of Rs 8.25 (Rupees Eight and Twenty Five Paise Only) are hereby invited form Bonafede Caterers for running the Majuli Bhawan Canteen, Jorhat including House Keeping. Interested Caterers/Persons having sound financial background and minimum 03 (three) years experience in catering to establishments i.e. Hotel, Guest House/Circuit House with sufficient knowledge of the local cuisines of Assam may apply. The last date and time of receiving shall be on 26th February, 2024 upto 02:00 PM and will be opened on the same day or the next day if it falls on holiday at 04:00 PM in the presence of the Tender committee & Bidders or their authorized representatives, if any willing to remain present at the time of opening of Bid documents.

TERMS AND CONDITIONS:

1. Application should be addressed to the District Commissioner, Majuli and super scribed As "APPLICATION FOR RUNNING OF THE CATERING AND HOUSE KEEPING SERVICE IN MAJULI BHAWAN, JORHAT".

2. Interested persons/parties must quote their rates of each item as per Menu Chart

3.i) Selected applicants shall have to deposit an amount of Rs. 2,00,000.00 (Rupees Two Lakhs) Only as "Security Deposit" for the use of the space etc. at the time of receiving work order.

ii) The catering service will be provided to persons who are occupied/allotted the rooms of Majuli Bhawan only. Outsiders other than occupant of Majuli Bhawan are not

allowed, without prior clearance of DC, Majuli.

4. The Contractor will engage Canteen Staff over the age 18 years only in accordance with labour laws.

5. The Contractor will keep the canteen neat and clean.

6. The Contractor have to maintain sufficient stock of utensils/crockeries/plates etc. to meet requirement for his day-to-day activities as well as during visit of VVIPs/VIPs.

7. Other than VVIPs/VIPs, the Contractor will have to ensure service of food items to

inmates/guests staying at Majuli Bhawan through his staffs.

8. During special occasions, refreshments tea, snacks, cold drinks, lunch, dinner etc. to be served by the Canteen at reasonable rate fixed by the Majuli Bhawan Authority i.e. DC, Majuli. The bill for such services provided by the Contractor will be submitted to Nazarat Branch for necessary payment subject to availability of fund.

9. The selected caterer / contractor shall have to install fire extinguisher in the Canteen as

per requirement of Fire Brigade Services.

10. The Contractor shall notify list of staff employed by him from time to time and get their identity card issued from Majuli Bhawan Authority.

11. The Contractor & his staff should adhere to the Security norms of Majuli Bhawan, Garamur.

12. The Contractor will have to keep the canteen open from 06.00 AM to 10.00 PM for Monday to Sunday (Occasionally during VVIP visit the time for opening & closing of canteen will be informed by the Majuli Bhawan Authority.

13. Validity of the contract will be one year from the date of signing the Agreement to further continuation with the approval of the District Commissioner, Majuli.

- 14. The Contractor is required to maintain one refrigerator / oven to own expenses in the main canteen.
- 15. The Contractor will engage one of his staff for Washing of Utensils etc. on daily basis.
- 16. District Commissioner reserve the right to terminate the contract at any point of time after issuing maximum of 10 (ten) day notice, without assigning any reason thereof. In such an eventuality, the contractor will hand over the premises in neat and clean condition after removing all its equipment/utensils/belonging on the date expire of notice period. No claims will be entertained thereafter.

17. Tenderers will have to submit their (i) GST Reg. No. (ii) PAN Card, (iii) Bank Accounts details (iv), Mobile No. (v) Financially Sound Certificate from Banks and (vi) Food Safety License.

18. The Contractor will have to deposit an amount of Rs. 44,959.00 (Forty Four Thousand Nine Hundred Fifty Nine) only every month in advance, to the Circuit House

Management Accounts, as monthly rent.

B. FUNCTIONS OF HOUSE KEEPING.

- To maintain cleanliness of all Blocks of the Majuli Bhawan Building such as Sweeping & Wiping of rooms, corridors (daily basis) cleaning of dust cobweb, furniture, sofa, bathroom etc.
- Washing & Ironing of Bed Cover, Bed Sheet, Towel, Pillow Cover, Mosquito net, Curtain, Blanket etc.
